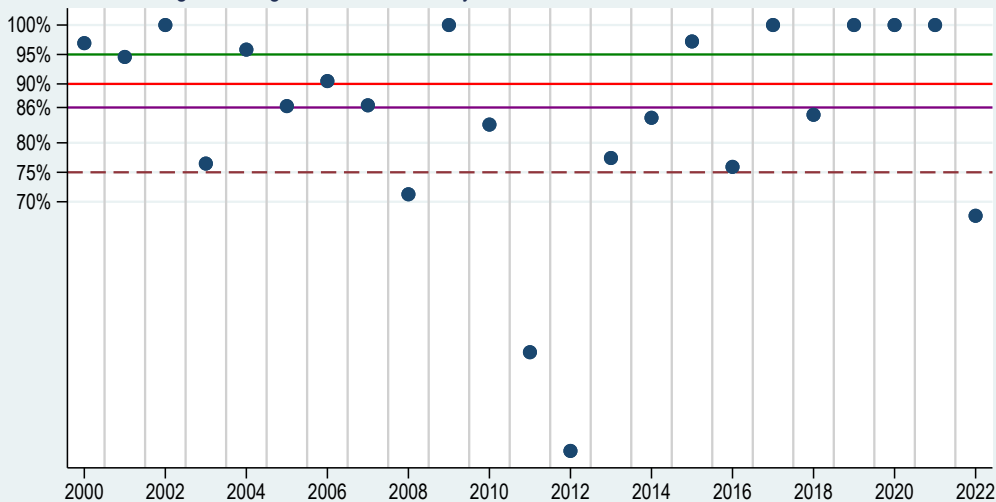
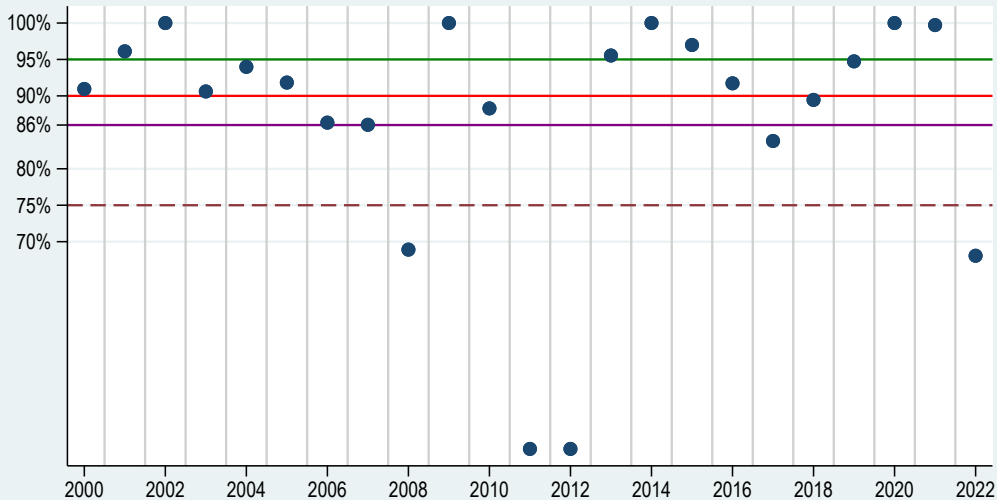


Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Allen County, Kansas



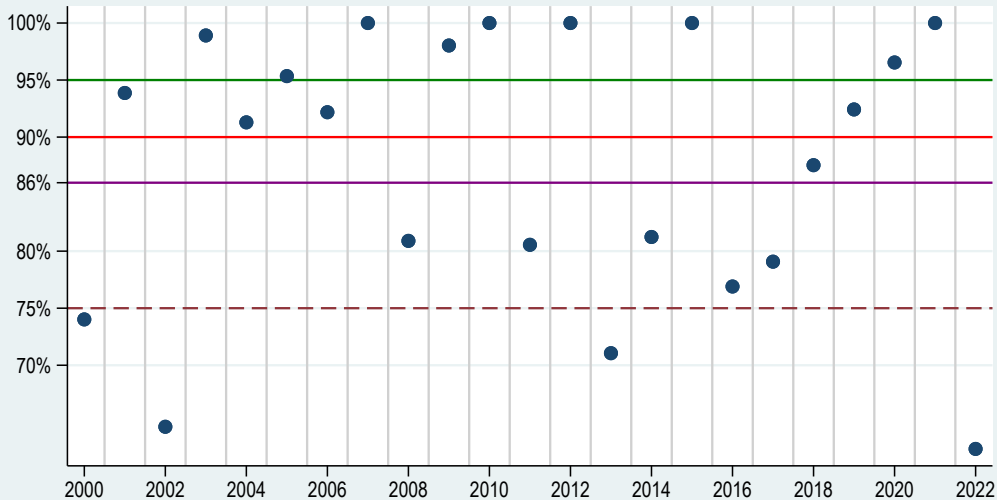

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Cherokee County, Kansas



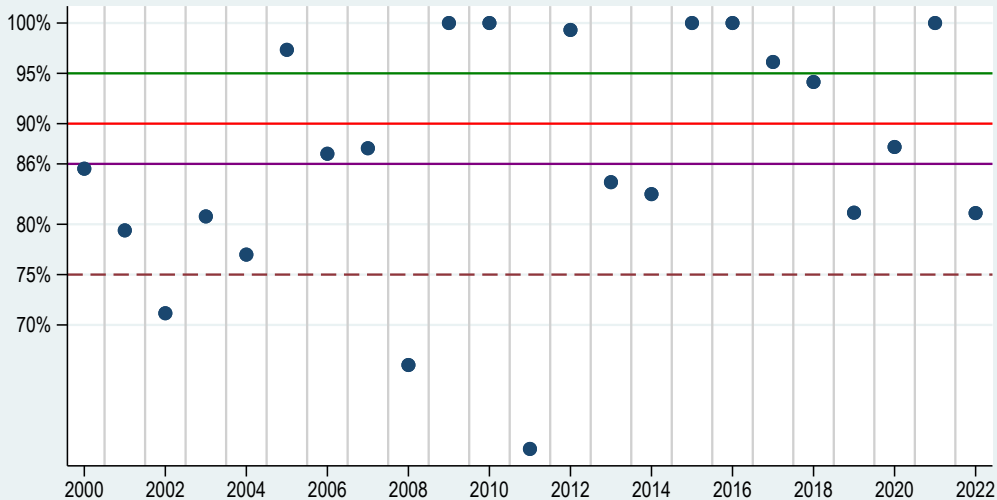

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Dickinson County, Kansas



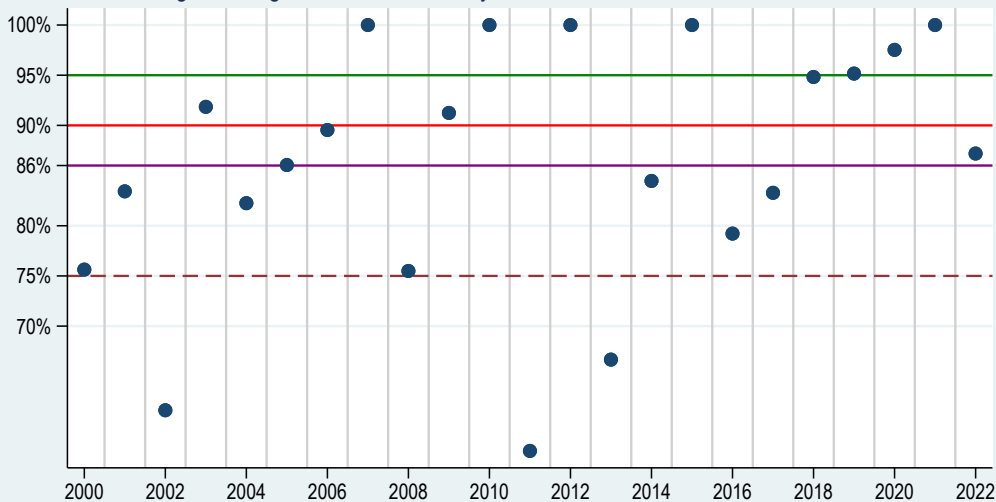

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Finney County, Kansas



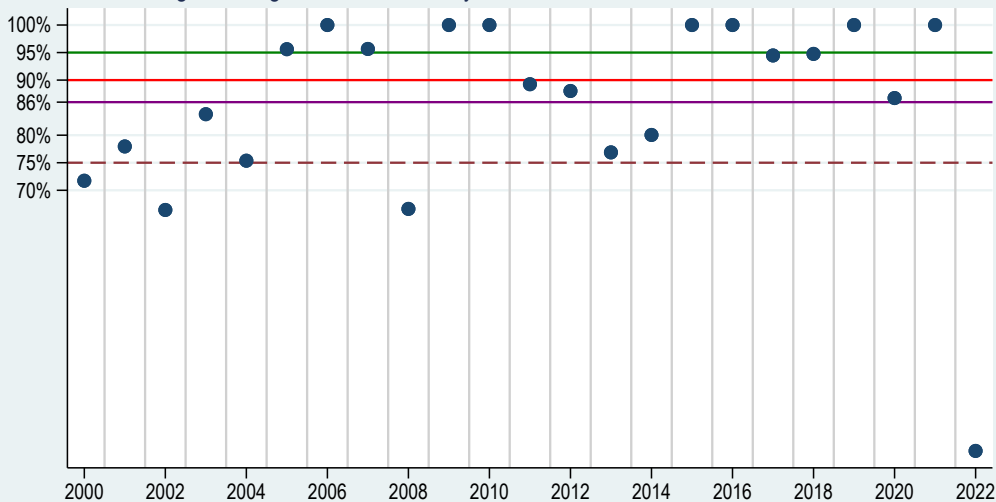

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Marion County, Kansas



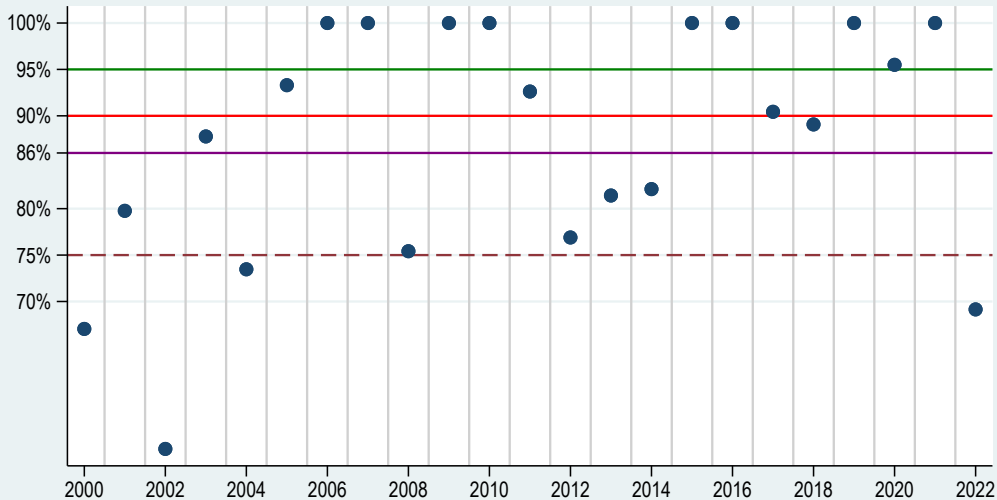

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Scott County, Kansas



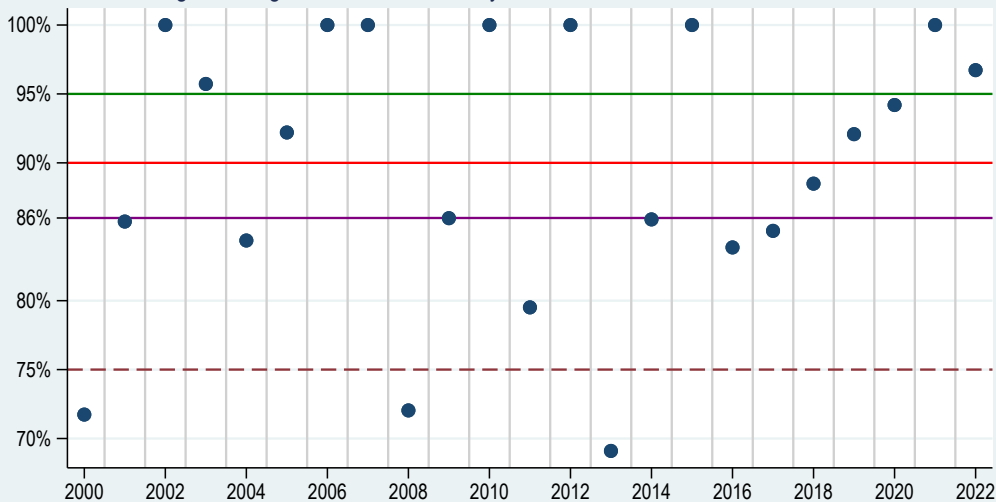

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Sherman County, Kansas



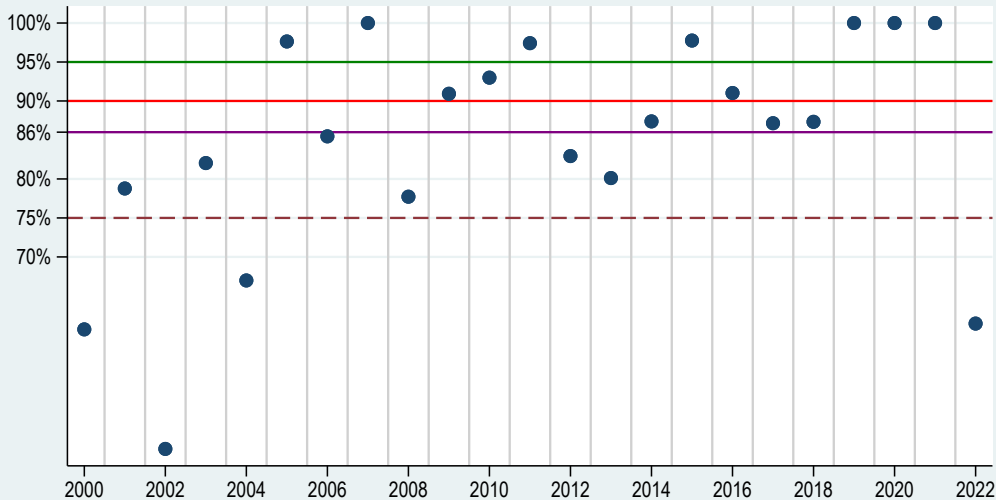

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Sumner County, Kansas



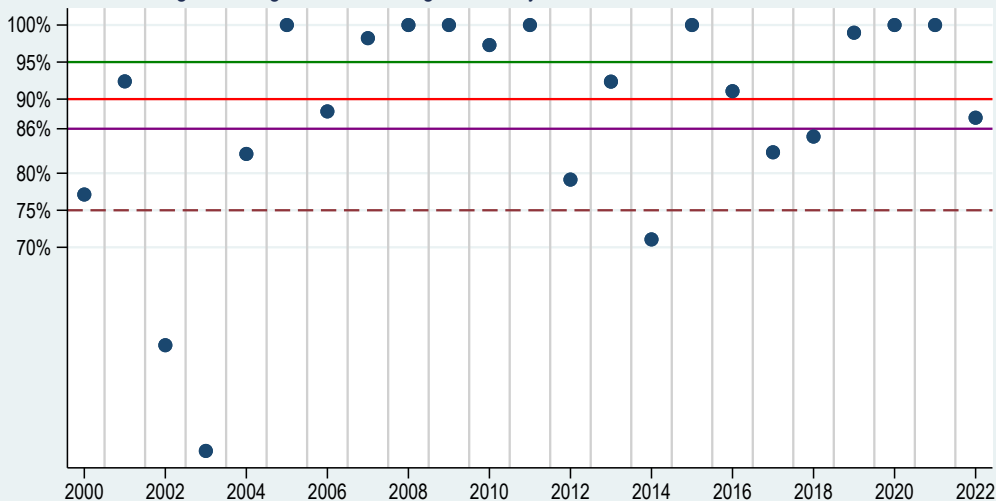

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Thomas County, Kansas



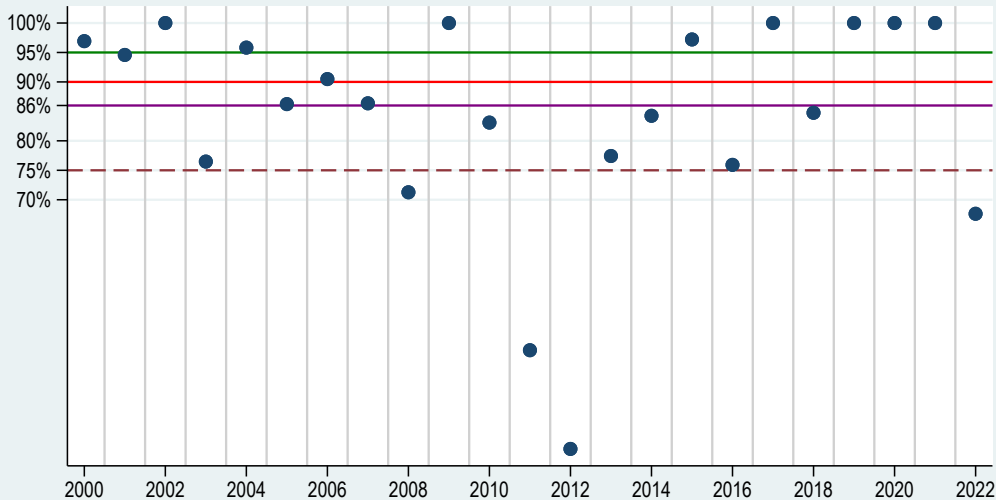

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Irrigated Sorghum in Washington County, Kansas



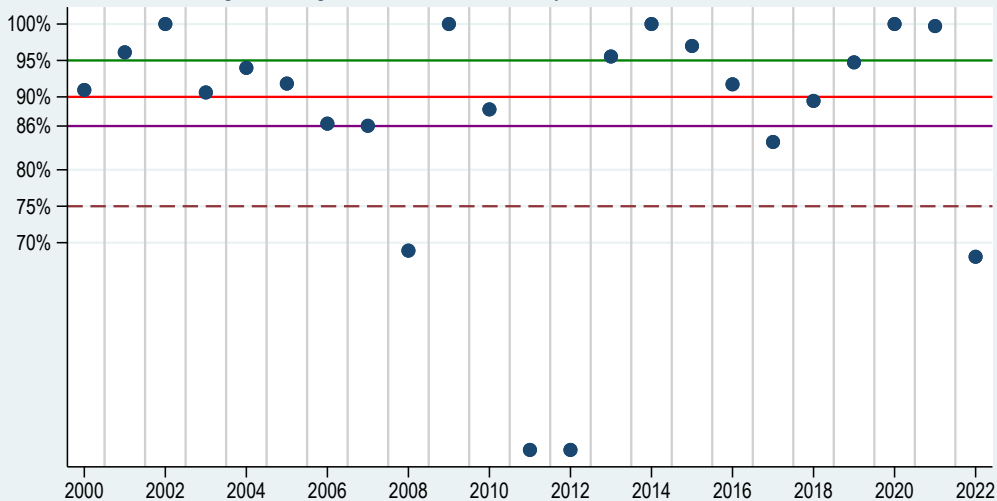

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Allen County, Kansas



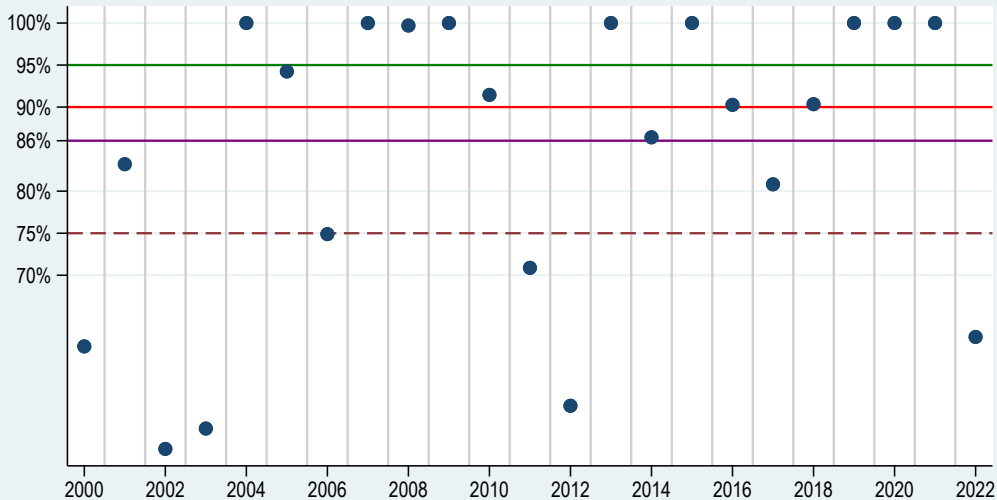

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Cherokee County, Kansas



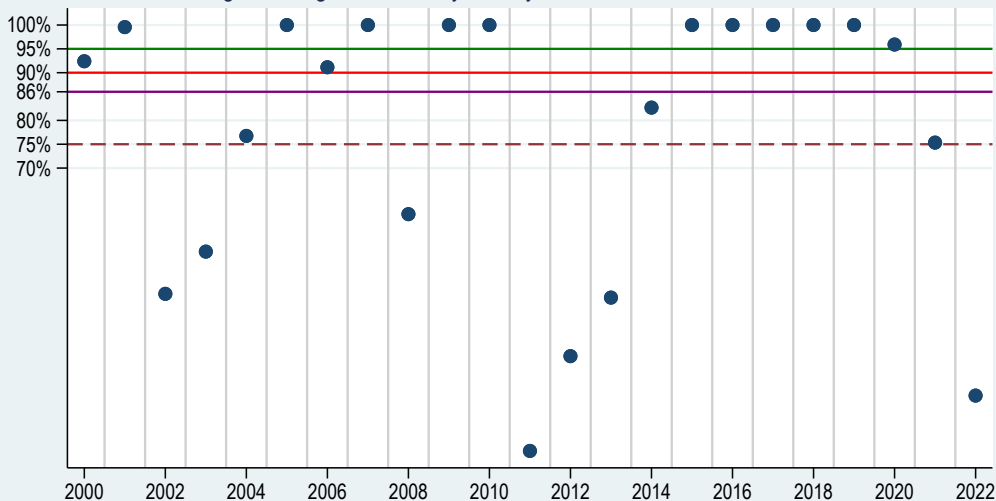

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Dickinson County, Kansas



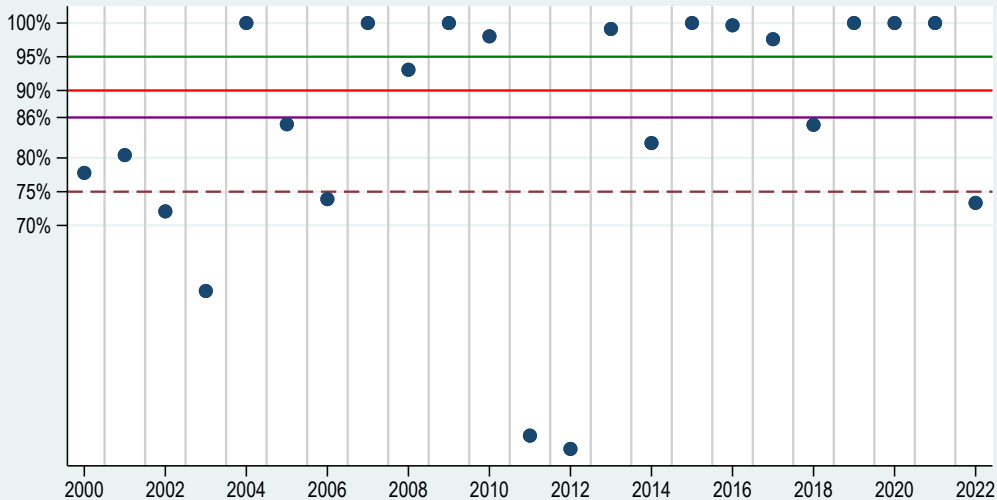

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Finney County, Kansas



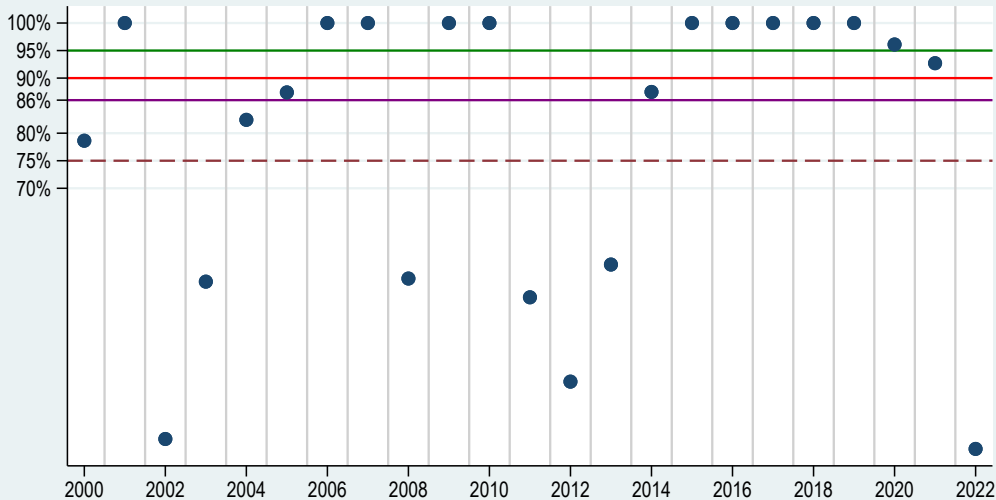

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Marion County, Kansas



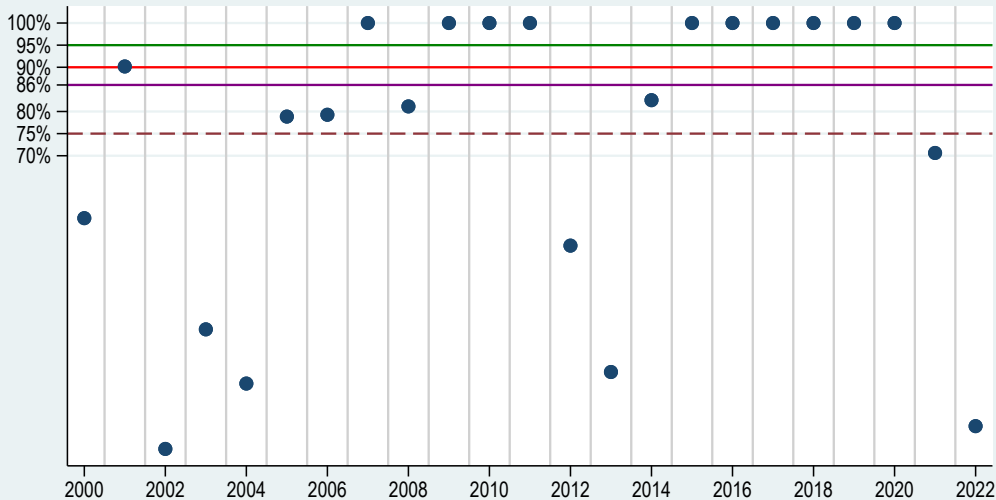

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Scott County, Kansas



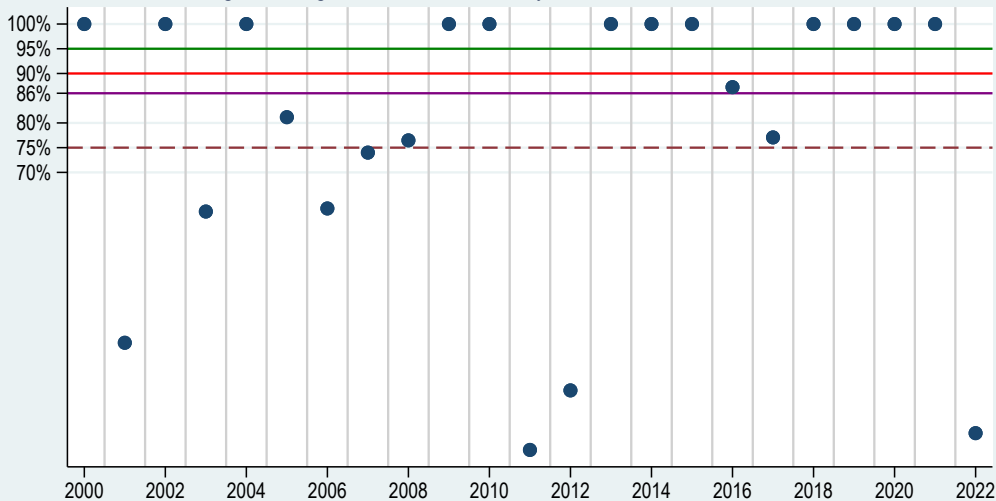

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Sherman County, Kansas



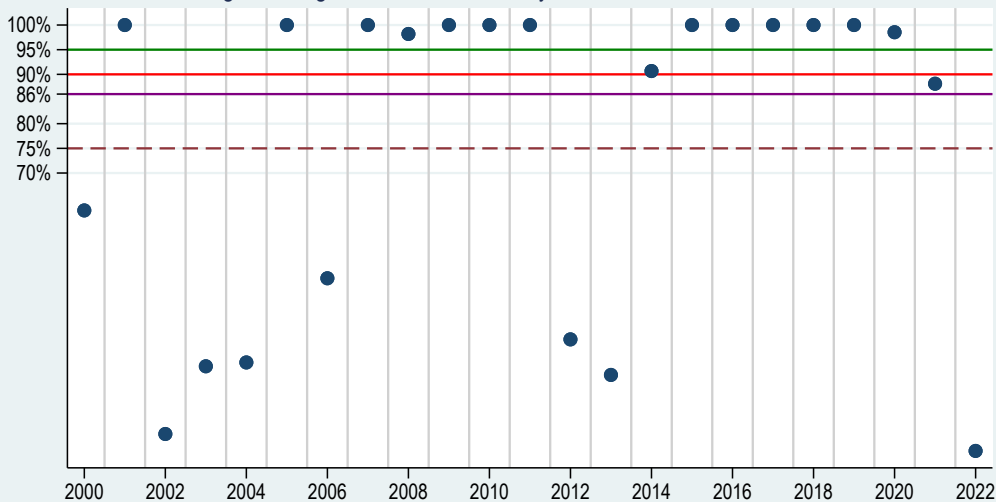

Estimated ratio of actual-to-expected revenue from 2000-2022 for RP (HPO), Non-Irrigated Sorghum in Sumner County, Kansas



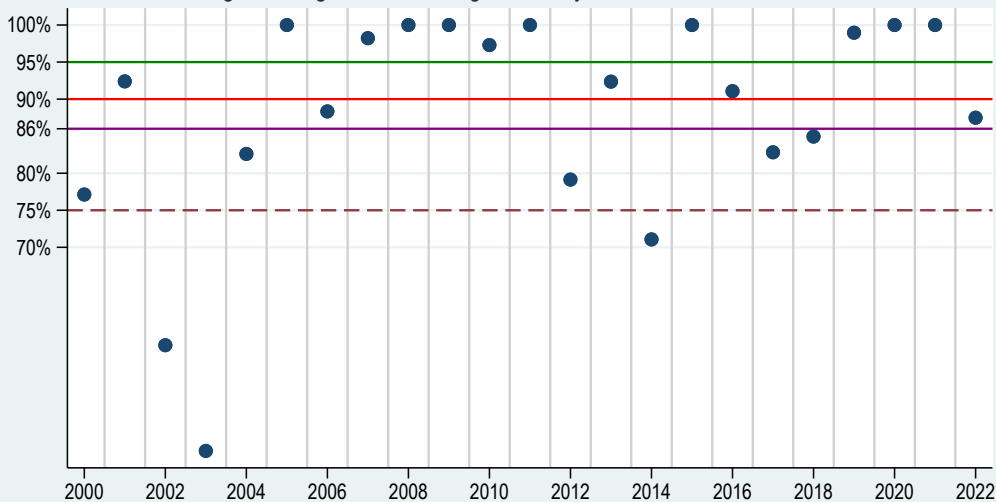
